**Report:**

**1. Purpose**

1.1 The purpose of this report is to provide information about the first year of the CityStudio Durham initiative. This report highlights the successes of this innovative partnership between the Regional Municipality of Durham, Durham Regional Police Service (DRPS), the Towns of Ajax and Whitby, and Durham Region's local postsecondary institutions (Durham College, Ontario Tech University, and Trent University Durham GTA).

**2. Background**

2.1 Staff from the CAO's office connected with CityStudio Vancouver after learning about their model of academic-municipal partnership at a municipal innovation conference. Durham staff saw the potential of a coordinated model to strengthen collaborations underway between the Region and our local postsecondary institutions.

2.2 Under a license agreement, the Region became the tenth municipality in Canada, and the first regional government to adopt the model. Staff from the CAO's office solicit project ideas from municipal staff that would benefit from collaborations with postsecondary faculty and students. In alignment with the post secondary semester timelines, project ideas are posted on a [public web portal](http://durham.ca/citystudio) (durham.ca/citystudio) where they are advertised to local postsecondary students and faculty who can express interest in collaborating. The CityStudio Durham coordinator then connects staff and faculty/students with similar interests to work out the details of getting projects started. At the conclusion of the fall and winter academic semesters, a live "Hubbub" event is held to share and promote the successful collaborations.

- 2.3 In the spring of 2020, Durham Region and DRPS launched the CityStudio Durham portal as part of a five-year pilot project.

### 3. Previous Reports and Decisions

- 3.1 With almost 30 projects complete, the outcomes and impacts of CityStudio Durham projects have been highlighted in a variety of presentations and reports, including:
- a. [#2020-COW-22](#): CityStudio Durham was endorsed as part of the [Regional Recovery Framework and Action Plan](#).
  - b. [#2021-F-5](#): Expanding the CityStudio Durham initiative was endorsed as a strategic priority in the [2021 Durham Budget](#).
  - c. [#2021-INFO-55](#): The number of completed CityStudio Durham projects was highlighted in the 2020-2024 Strategic Plan Year One Progress Update.
  - d. The CityStudio Durham project “Barriers to Accessing Services for People with Disabilities” was mentioned at several Accessibility Advisory Committee meetings ([AAC 03232021](#), [AAC 01262021](#), [AAC 11242020](#), [AAC 10012020](#)).
  - e. The CityStudio Durham project “Trail Safety in Durham Region” was mentioned at the [DATC 03112021](#) Durham Active Transportation Committee meeting.
  - f. Other CityStudio Durham projects have been mentioned in previous Council Information Reports ([#2020-INFO-110](#), [#2020-INFO-84](#)).

### 4. Outcomes of Collaborations

- 4.1 CityStudio Durham completed its first group of 10 projects in the Fall 2020 academic semester, and an additional 19 in the Winter 2021 academic semester.
- 4.2 Collaborations have involved staff from all Regional Departments and DRPS, as well as faculty and students from multiple Faculties and Schools across all three of Durham’s local postsecondary institutions.
- 4.3 Several more projects are currently underway in the Summer 2021 academic semester and staff are working with the postsecondary schools to plan projects for the Fall 2021 academic semester and beyond.
- 4.4 To evaluate the experience of participating in the program, staff, faculty, and students were surveyed about their work on a CityStudio Durham project. Responses were rated on a scale from 1-5, with 5 being most positive. The responses were overwhelmingly positive. For examples, students ranked their experience working in the CityStudio Durham program as 4.8/5 citing that it provided a valuable learning experience. Staff at the Region ranked their experience working in the CityStudio Durham program as 4.5/5 citing that the students brought new perspectives that helped inform improvements in programs and service delivery (Figure 1).

Quotes from CityStudio Durham participants:

- a. **Trail Safety in Durham Region:** “The impact of the project will be seen in future policy work as it will help to bring awareness and discussion of trail safety. The recommendations will help to either bring new ideas forward or put ideas listed in the report to action to increase general safety.” – Brittany Mohammed, student, School of Justice and Emergency Services, Durham College.
- b. **Preventing At-Risk Behaviours in Young Children Within Early Learning Environments:** “The rebuilding the village project looked at interventions for at-risk behaviours in children five years of age or younger. For my research in my practicum I looked at early childhood education curriculum in the Greater Toronto Area to see where there are courses that are teaching interventions for at-risk behaviours, and if not where the gaps are and what can be done to better help early childhood educators identify at-risk behaviours”. – Lorelei Stolpmann, student, Faculty of Social Sciences and Humanities, Ontario Tech University.
- c. **Community Hubs for Vulnerable Populations:** “The goal of this project was to develop a sustainable model that merges health and homelessness sectors to provide fully integrated, low barrier wraparound supports for residents experiencing homelessness in Durham. I was interested in this project because being a student at the Ontario Tech downtown campus I could see homelessness was an interest in Oshawa, and I was interested in being part of a project that could support these individuals.” – Drishika Bikraj, student, Faculty of Social Sciences and Humanities, Ontario Tech University.
- d. **The Economic Impact of Municipal Investments:** “We estimated local economic impact multipliers for different municipal infrastructure projects, including water supply, sanitary sewage, transportation, facilities, fleet, and equipment. Increased municipal investment is positively associated with increase in GDP, employment, GDP per capita, and personal income per capita in Durham region from 2012 to 2019. Splitting up infrastructure investment shows that investments in water supply, sanitary sewage, transportation, facilities, fleet, and equipment have all contributed to the Region’s economic growth. We provided suggestions on how the Region can prioritize future infrastructure projects based on the comparisons of quantitative data results.” – Yi Liu, Professor, School of Business, Trent University Durham GTA.
- e. **Impact of Digital Transformation on Urban Growth:** “The student delivered a research report and presentation which was very informative and well presented. The contents of the presentation will be an important input into understanding our strategy with respect to commercial space availability with

COVID 19 impacts and beyond. The project impacted some of our team's pre-conceived notions about how organizations are thinking about office space. It provided valuable insight and has made us re-think how we should approach our strategies in the future." – Taran Sambhi, Program Coordinator, Economic Development Division, Department of Planning and Economic Development, the Regional Municipality of Durham.

## 5. Other Accomplishments

- 5.1 A [public web portal on durham.ca](https://durham.ca/citystudio) was launched in September 2020 (durham.ca/citystudio), along with a comprehensive communications campaign, including an official press release announcing the launch of CityStudio Durham on September 21, 2020.
- 5.2 The Town of Ajax officially joined CityStudio Durham as the first local area municipality partner in December 2020. The Town of Whitby joined in March 2021. Others have expressed interest in participating.
- 5.3 Regional staff hosted two virtual Hubbub events in December 2020 and April 2021, aligning with the end of the student term, to share the outcomes of their work from Fall 2020 and Winter 2021 projects.
- 5.4 Three funding applications to support research projects were submitted to Mitacs, a Canadian non-profit funding agency. All three funding applications were successful, bringing in \$37,500 of funding to support the research.
- 5.5 In collaboration with Legal Services, standardized research agreement templates were developed between the Region and postsecondary schools. This will streamline the process of initiating projects, especially those involving funding.

## 6. Future Plans

- 6.1 Staff in the CAO's office are establishing a method to collect data to capture the long-term impact and application of the results of CityStudio Durham projects, and building on the success of part-time student placements to develop a program to enable Regional groups to host longer-term, full-time student fellowships under the CityStudio Durham umbrella.

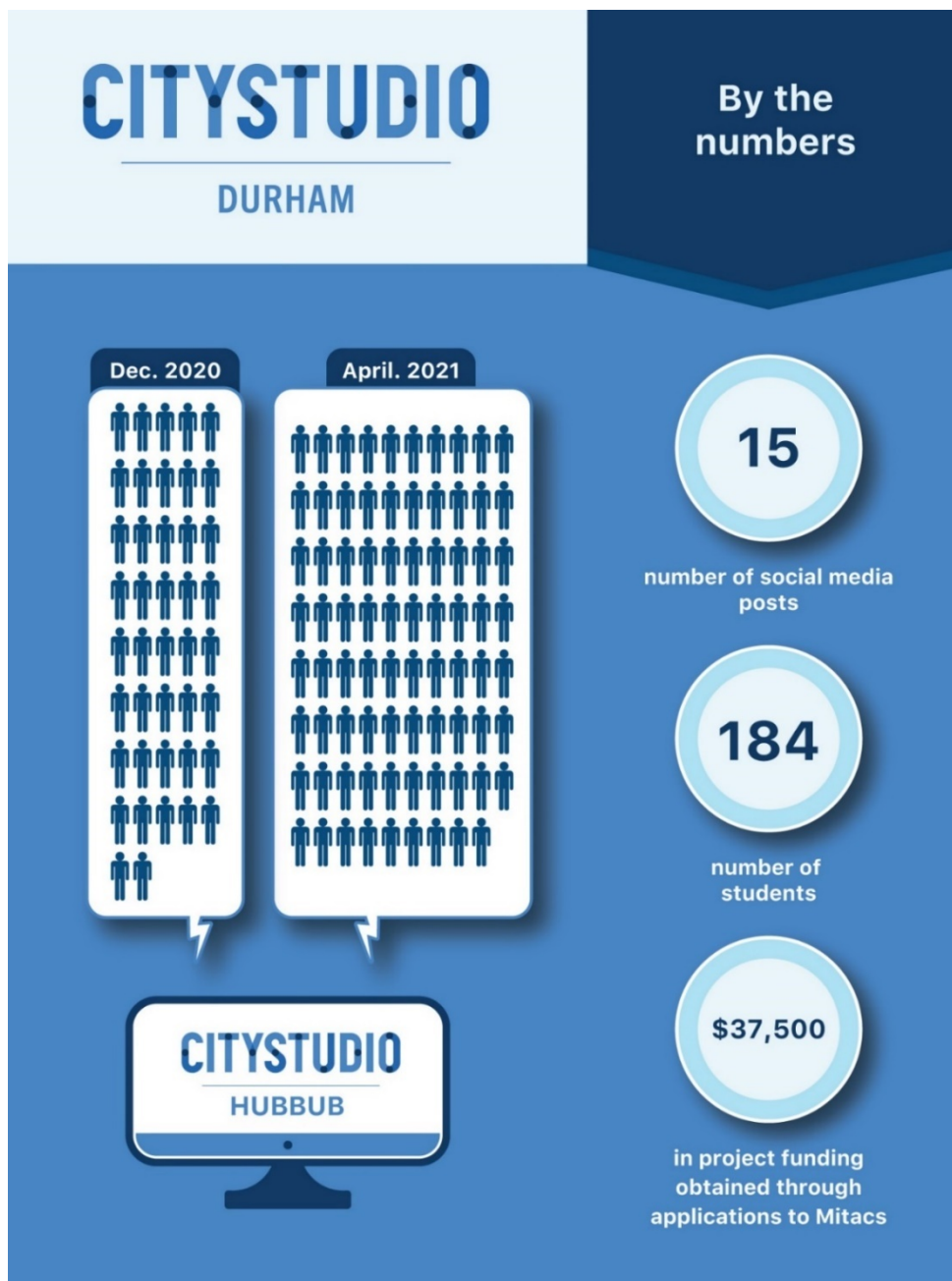
## 7. Relationship to Strategic Plan

- 8.1 The first year of the CityStudio Durham initiative has been a success, with high levels of engagement from Regional staff and postsecondary faculty and students.
- 8.2 Almost 30 projects were completed between September 2020 and April 2021, with many more underway or planned to start in the Fall of 2021.
- 8.3 Regional staff will build on the success of the first year of this pilot project and continue to support the growth of this initiative and track its long-term outcomes and successes.

**Report:**

**1. Purpose**

1.1 To provide an update on the results of the Ministry of Health's (MOH's) ambulance service preliminary review of Region of Durham Paramedic Services (RDPS), received on June 11, 2021.

**2. Background**

- 2.1 The [Ambulance Act](#) stipulates that all ambulance service providers must successfully complete a certification process to operate.
- 2.2 The MOH conducts ambulance service reviews every three years to confirm that service providers continue to meet legislated standards.
- 2.3 There are two possible outcomes of the review; either the service provider does or does not satisfy the legislated requirements. If the service provider satisfies the certification standards, its certificate will be renewed for three years.
- 2.4 RDPS' certificate expires on November 20, 2021 and the ambulance service review is required for RDPS' recertification.
- 2.5 Due to the COVID-19 pandemic, the MOH developed an ambulance service preliminary review process which was conducted off-site. Once normal review activities resume, RDPS will be contacted to schedule an on-site review.

### 3. Service Review Highlights

- 3.1 The ambulance service preliminary review found that RDPS has met the requirements for certification in compliance with Ontario's Land Ambulance Certification Standards, as amended, in accordance with [O. Reg. 257/00](#).
- 3.2 The preliminary review involved RDPS' participation in the following activities:
  - a. An off-site inspection.
  - b. Completing a checklist.
  - c. Providing comments and/or supporting documents upon request.
  - d. Participating in an exit interview to discuss observations.
- 3.3 The ambulance service review focuses on three main areas: patient care; quality assurance; and administration. As the preliminary review was conducted off-site, there are some activities within these focus areas which will be reviewed later, during an on-site review.
- 3.4 The ambulance service preliminary review team outlined five observations to highlight opportunities for improvement in the following areas:
  - a. Calibrating RDPS' oxygen testing equipment according to the manufacturer's specifications.
  - b. Documentation of quality assurance program components.
  - c. Documentation of staff review of the Ambulance Call Report Completion Manual and Ontario Ambulance Documentation Standards.
  - d. Meeting Canadian Triage Acuity Scale (CTAS) targets identified in the Response Time Performance Plan.
  - e. Ensuring sufficient staffing numbers at each level of qualification to meet the deployment plan.
- 3.5 RDPS has responded to the MOH's observations and has already taken the following actions, which address some of the observations of the preliminary review team:
  - a. Implementation of a system to better track the calibrating schedule of oxygen testing equipment.
  - b. Changes to the deployment plan to improve achievement of CTAS targets.
  - c. Hiring additional staff and returning some staff to 911 operations that were previously deployed to support pandemic response.
- 3.6 Some of the observations noted by the preliminary review team reflect the challenges with conducting an off-site review and will be resolved through an on-site visit.

#### **4. Relationship to Strategic Plan**

- 4.1 This report aligns with/addresses the following strategic goals and priorities in the Durham Region Strategic Plan:
- a. Goal 5: Service Excellence – To provide exceptional value to Durham taxpayers through responsive, effective, and fiscally sustainable service delivery.

#### **5. Conclusion**

- 5.1 The MOH completed an ambulance service preliminary review of RDPS to assess its compliance with legislation for recertification.
- 5.2 A preliminary off-site review process was implemented due to the COVID-19 pandemic.
- 5.3 RDPS has successfully met the legislated requirements for certification as a land ambulance operator in Ontario.
- 5.4 RDPS has implemented process changes which address some of the observations noted by the MOH's preliminary review team. Any remaining observations will be addressed through an on-site review.
- 5.5 An on-site review will be scheduled once normal activities resume.

**RE: Bill 279 – Environmental Protection Amendment Act (Microplastics Filters for Washing Machines), 2021**

**WHEREAS** microfibers are human-made strands less than 5mm composed of either synthetic or natural materials. Microfibers are shed through the wear and tear of textiles through the laundering process;

**WHEREAS** billions of microfibers are released into the Great Lakes daily from machine laundering of clothes. Studies have found a single load of laundry can release up to millions of microfibers into washing machine effluent, which flows to the wastewater treatment plant. Wastewater treatment can capture up to 99% of microfibers in sewage sludge, but microfibers are still released into aquatic ecosystems through treated effluent. Billions of microfibers are released into the aquatic ecosystem daily in the Great Lakes basin, either directly via treated final effluent, or indirectly as runoff from land-application of treated sewage sludge; and

**WHEREAS** microfiber contamination is widespread: Worldwide and local studies have shown microfibers present in commercial fish, Great Lakes fish (including Lake Trout, Rainbow smelt, Brown bullhead, etc.), honey, salt, Great Lakes beer, tap water, bottled water and much more; and

**WHEREAS** microfibers are the most prevalent type of microplastics in the environment and have been found in surface water, soil, biota, and atmospheric samples; and

**WHEREAS** a 2014 surface water study in Lake Erie, Lake Ontario, and their tributaries measured microplastics at abundances between 90,000 and 6.7 million particles per square kilometer. These levels of microplastics are similar to or exceed concentrations found in ocean gyres like the “Great Pacific Garbage Patch; and

**WHEREAS** microplastics do not biodegrade; and

**WHEREAS** chemicals such dyes and flame retardants are added to textiles during manufacturing. Textiles can also absorb chemicals from their environment after manufacturing. Some of these chemicals are toxic, and harmful chemical compounds can be released into the environment via leaching from microfibers; and

**WHEREAS** a growing body of research shows that the effects of microplastics on animal life are far-reaching. Researchers have investigated the impacts of microplastics on gene expression, individual cells, survival, and reproduction. Mounting evidence shows that negative impacts can include decreased feeding and growth, endocrine disruption,

decreased fertility, and other lethal and sub-lethal effects. Some of these effects are due to ingestion stress (physical blockage), but many of the risks to ecosystems are associated with the chemicals in the plastic. Studies have shown that chemicals transfer to fish when they consume microplastics. When these fish end up on our dinner plates, we potentially increase the burden of hazardous chemicals in our bodies; and

**WHEREAS** a recent set of laundering experiments in the laboratory; have shown that an external filter can capture an average of 87% of fibres by count and 80% by weight before they go down the drain (McIlwraith et al. 2019). On a wider scale and in real-life context, Georgian Bay Forever, the University of Toronto and the Town of Parry Sound are completing a study that is measuring the effect that about 100 filters in households has on reducing microfibre pollution in the effluent of a wastewater treatment plant. The results of this study are to be released in August; and

**WHEREAS** add-on filters cost approximately \$180-220 CDN to purchase and install, which is prohibitive for the average household. Accordingly, voluntary adoption rates are low; and

**WHEREAS** France has passed legislation (France 2020-105, Article 79) that requires future washing machines sold to have filters. California has introduced a bill (California AB 622), and Ontario has tabled Private Member's Bill 279 to prohibit sales of washing machines without a filter of mesh size 100 microns or smaller. Companies such as Arclik have manufactured washing machines with filters built directly into them;

**NOW THEREFORE BE IT RESOLVED** that the Great Lakes St. Lawrence Cities Initiative (Cities Initiative) recognizes that to date the largest documented source of environmental microfibers is washing machines, and that findings indicate washing machine filters mitigate the majority of fibres shed during machine washing; and

**BE IT FURTHER RESOLVED** that the Cities Initiative recognizes the need to require future sales of washing machines to include filters with a maximum mesh size of 100 microns; and

**BE IT FURTHER RESOLVED** that the Cities Initiative and its members call on the Ontario government to pass Bill 279, and to call on the Canadian and U.S. government to create appropriate regulatory measures to the same effect; and

**BE IT FURTHER RESOLVED** that until households can only buy new laundry machines outfitted with <100 micron filters, the Cities Initiative and its members call on provincial, state and federal governments to provide funding and education to help constituents reduce microfiber waste.

**BE IT FINALLY RESOLVED** that Council for the Corporation of the Township of The Archipelago directs its staff to submit this resolution to the Great Lakes St. Lawrence Cities Initiative; and forward this resolution to all municipalities in the Great Lakes watershed and to Federal and Provincial Representatives.



**Whereas** many hard-working Canadians who have only a primary residence with no additional non-primary homes count on their home equity as financial aid to apply to upsizing or downsizing their home depending on their personal situation, and

**Whereas** a change in taxation to primary residences would be a significant financial blow to Canadians and would create an unfair, two-tiered taxation which could lead to depleted savings, inter-generational disparities, disparities among diverse groups such as seniors who may have a significant portion of their savings vested in their primary residence, as well as, reducing the ability of home ownership thereby a further, higher need for rentals, and

**Whereas** the Federal government could look at other means to slow down the rapidly escalating housing costs to improve housing affordability;


