2. April 2022 By-Name List Update, Alyx Riddell

- April 2022 By-Name List Data:
 - 271 people actively experiencing homelessness on the By-Name List 167 of whom are experiencing chronic homelessness
 - There were 16 move-ins in April
 - 10 of those move-ins were people experiencing chronic homelessness We have had 55 total move-ins in so far in 2022 from the By-Name List, 33 of whom were experiencing chronic homelessness (60% of overall move-ins)
 - For comparison, from January to April 2021 we had 68 total move-ins, 36 of whom were experiencing chronic homelessness (53% of overall moveins)
- There have been fewer move-ins overall compared to 2021. However, the percentage of move-ins for people experiencing chronic homeless has increased
- Built for Zero Monthly Report Card April 2022. <u>Built For Zero Report Card (durham.ca)</u>.

3. Spirit of Service Presentation, Christopher White and Ben Earle

- A presentation on the Spirit of Sponsorship pilot that was supported through donations and the Spirt of Service is requesting ongoing funding to continue the program.
- Four participants have completed the first pilot which involved housing and supporting homeless individuals with wrap around supports from volunteers and a collaboration with community organizations. Volunteers who supported the individuals participated in a 4-week trauma informed training program based out of Ontario Tech. With the success of the participants and the pilot, Spirit of Service is seeking sustainable funding to continue the program.
- A request of \$85,000 for funding would allow the program to run another year, and \$150,000 for an expansion to include more program participants. The budget request also includes a staff from Carea to support the participants. Increased funding would allow more participants based on their complexity.

4. Update on New Service Sector Model, Erin Valant

- Brief overview of the presentation that was shared in the last meeting regarding the restructuring the homelessness committees' model to be based on sectors of service.
- Contact lists for co-chairs for updated committee model is attached along with a brief overview of each sector table. Attachment #1
- As the sector tables will be meeting every other month to implement improvement projects, it was decided DACH meetings will happen quarterly. The quarterly DACH meetings will include a full update from each of the sector tables for feedback, any decisions that need to be

made by DACH, etc. The new quarterly agenda template was shared for feedback from the DACH membership.

5. HIFIS Update - Kazzrie Cormick, Community Development Council Durham

The priority for 2022 is accurate and consistent data collection in HIFIS. Rights have been changed in HIFIS, and restrictions have been implemented to ensure accuracy. Reports will be more accurate as a result of the restrictions. Contacts will be reviewed to ensure people who have access to HIFIS are still working in the sector. The HIFIS training manual will be updated and refresher training for agencies will be provided. The By-Name List will also be built into HIFIS. Data integratory checks will happen, and reports will be sent to the Region of Durham. The goals with HIFIS are in alignment with our system goals for the rest of the year. Accurate data in HIFIS will help system planning going forward.

6. Seeking Input from DACH on Shelter Capacity and Solutions

- There is an increasing number of inquiries from agencies needing shelter space. Shelters and motels are at capacity and projected to be going forward. There has been an increase in the number of families, as well as an increase in people who have never experienced homelessness before becoming homeless.
- This is similar to other areas across the GTA.
- At this time there is no surplus provincial or federal homelessness funding available to support any new initiatives. Decisions need to be made on how to support expanding shelter capacity, including the possibility of reducing other services.
- There was discussion regarding engaging faith-based communities across Durham to help support families experiencing homelessness.
- There was also discussion to provide shelter diversion training for all staff within the homelessness support system to try and divert people from shelter whenever safe and appropriate.

System Sector Information

Shelter Sector

Aims to support anyone experiencing homelessness with immediate shelter. Durham's shelter system is Housing-Focused - the goal of the shelter sector is to divert people from needing to access shelter whenever safe and appropriate and to help people exit shelter to housing as quickly as possible.

Street Outreach Sector

Aims to help people experiencing unsheltered homelessness to be added to the By-Name List, supported with immediate needs, be connected to a dedicated street outreach case manager and housed. The goal of the Street Outreach Sector is to match people who are unsheltered on the By-Name List to a dedicated Street Outreach Case Manager as quickly as possible, and then for that case manager to help the person become housed as quickly as possible.

 Standardizing street outreach across Durham so that all street outreach teams are working in the same way (continuing to build more detail into the Street Outreach Strategy)

Hubs & Day Services Sector

Aims to engage people experiencing homelessness who are not yet on the By-Name List and to ensure they are added and document ready (document ready means that they have their identification, income source, etc.) Also provides meaningful daily activities for people experiencing homelessness – and also for people who have been housed to maintain social connection.

- Identifying or building partnerships to provide daytime programming
- Developing a weekly schedule of daytime programming that people can access

Homelessness Prevention Sector

Aims to help people at risk of homelessness to maintain their housing or obtain new housing without ever becoming homeless. Also includes upstream prevention work with youth, helping people to understand their rights and responsibilities as tenants, etc. The goal of the Homelessness Prevention Sector is to stop as many people as possible from becoming homeless, and to help people new to homelessness exit as quickly as possible.

Housing Outflow Sector

Aims to house as many people from the By-Name List as efficiently and effectively as possible. Also includes developing best practices, identifying new programs/models to implement, etc. The goal for the Housing Outflow Sector is to house as many people from the By-Name List as possible and ensure they remain housed, and to continuously onboard new housing opportunities.
