

## By-law Number 30-2022

### of The Regional Municipality of Durham

Being a by-law to amend By-law Number 03-2021 which regulates traffic and parking on roads under the jurisdiction of the Regional Municipality of Durham.

Now therefore, the Commissioner of Works of The Regional Municipality of Durham hereby enacts as follows:

1. That **Schedule II (No Parking)** be amended by **deleting** thereof the following:

Regional Road 45 (Henry Street)	East	Burns Street West and Harriet Street extended	8:30 a.m. to 4:30 p.m. Monday to Friday, September 1 to June 30
Regional Road 45 (Henry Street)	East	St. John Street West and Gilbert Street West extended	8:30 a.m. to 4:30 p.m. Monday to Friday, September 1 to June 30
Regional Road 45 (Henry Street)	East	Gilbert Street West extended and 32 metres south of Colborne Street West	Anytime
Regional Road 45 (Henry Street)	West	Burns Street West and Harriet Street	8:30 a.m. to 4:30 p.m. Monday to Friday, September 1 to June 30
Regional Road 45 (Henry Street)	West	Harriet Street and St. John Street West extended	Anytime
Regional Road 45 (Henry Street)	West	St. John Street West and Gilbert Street West	8:30 a.m. to 4:30 p.m. Monday to Friday, September 1 to June 30
Regional Road 45 (Henry Street)	West	Gilbert Street West and 47 metres south of Colborne Street West	Anytime

2. That **Schedule XIII (Through Highways)** be amended by **deleting** thereof the following:

Regional Road 43	The north limit of Dundas Street and the south limit of Walnut Street
Regional Road 43	The north limit of Walnut Street and the south limit of Regional Road 28 (Rossland Road)
Regional Road 45	The north limit of Regional Road 22 (Victoria Street) and the south limit of Dunlop Street
Regional Road 45	The north limit of Dunlop Street and the south limit of Dundas Street

3. That **Schedule XIII (Through Highways)** be further amended by **adding** thereto the following:

Highway	Between
Regional Road 28	The east limit of Lake Ridge Road (Regional Road 23) and the west limit of Regional Road 33 (Harmony Road)

4. That **Schedule XIV (Stop Signs)** be amended by **deleting** thereof the following:

Intersection or Portion of Highway	Direction
Regional Road 43 (Cochrane Street) at Walnut Street	Northbound and southbound on Regional Road 43 (Cochrane Street); eastbound and westbound on Walnut Street
Regional Road 45 (Henry Street) at Dunlop Street	Eastbound and westbound on Dunlop Street; northbound and southbound on Regional Road 45 (Henry Street)

5. That **Schedule XVI (Maximum Rate of Speed)** be amended by **deleting** thereof the following:

7. That Schedule **XIX (School Bus Loading Zones)** be amended by **deleting** thereof the following:

Regional Road 45 (Henry Street)	West	80 metres south of St. John Street (extended)	35 metres south of St. John Street (extended)

8. That Schedule **XXI (Community Safety Zones)** be amended by **adding** thereto the following:

Highway	Between	Time of Day	Days/Months of Year
Regional Road 28 (Rossland Road)	Cochrane Street to Coronation Road	Anytime	All days/months
