#### 3. DISCUSSION:

Erin Valant welcomed Michelle Willson, CAO of the Township of Brock to the Committee and introduced guests to the meeting. Everyone at the meeting introduced themselves.

# A. Project Update

 Erin provided an update on the projected opening date noting that after the building is complete, time is required to complete inspections prior to building hand-off.
 Once that has occurred, Blue Door will have full access to the building.

- Anticipating initial occupancy mid/end of summer. Blue Door will have an
  opportunity to spend time at the building to finish staff training and building setup
  prior to initial occupancy.
- Rachel advised that Adult Protective Services (APS) supported 31 clients through the Canada Ontario Housing Benefit (COHB) last year.

# **Question?**

• What happens when someone moves out of the building?

#### Answer:

 As with other transitional housing programs, housing benefits can be made available to support ongoing affordability as people move into independent accommodations. Rachel provided an example that Adult Protective Services (APS) supported 31 clients through the Canada Ontario Housing Benefit (COHB) last year in partnership with Housing Services.

#### B. Review of the Intake Process - Blue Door

- Alex and Amanda shared the draft Referral and Intake Process. Each member received a copy.
- In addition to discussion at the meeting, members can share feedback via e-mail to Erin.
- Blue Door explained the eligibility criteria and program parameters including the Occupancy Agreement and the Service Agreement. The Service Agreement includes a Good Neighbour component.
- Blue Door will work with occupants to identify and support their goals. Every
  occupancy will also need to commit to participating in the program and working
  towards independent housing.
- Occupants will complete an assessment every three months to identify changing support needs and goals to achieve. This includes discussion on volunteer goals, community integration and recreational goals, etc.
- The Minutes of Settlement helped to inform the intake policy.

#### Question?

• If at the end of 4 years the occupant has no place to go, what happens?

#### Answer:

• The goal is to find permanent housing within the 4 years. There are portable housing benefits to assist with affordability. Many existing transitional housing

programs are one-year in length and a four-year program provides significant opportunity to ensure successful move outs.

# **Question?**

• Do applicants have to live in Durham Region?

#### Answer:

• To be eligible for Durham's By-Name List, a person must be residing in Durham Region for at least 90 days. Those that may have left Durham but have a meaningful connection (such as family) may also be eligible.

#### Question?

• Can we predict a turnover rate of clientele?

#### Answer:

 Each person has unique experiences and support needs – some people may only need six months of support, while others may need more than two years. A fouryear program provides enhanced opportunity to ensure successful move outs. In addition, when someone moves out, they will have a comprehensive plan in place with community partners creating a wraparound approach for long term success. Clients will also be connected to a Blue Door staff for ongoing support.

### **Question?**

- Is Blue Door looking at implementing employment programs like Construct?
   Answer:
- Blue Door is exploring and planning for long term training programs for occupants.

## C. Community Tour Ideas

- Tours of the facility were discussed. There will be a tour for local councillors, elected officials, service providers and this committee prior to occupancy.
- A community tour or open house was discussed, and Committee members
  provided feedback that a video tour along with interviews of Blue Door and
  members of this committee as well as a graduate of transitional housing would be
  more beneficial.
- Erin will touch base with our Communications team and send out an email to see if anyone is interested in participating in a video.

- The next regularly scheduled meeting will be moved to August 12 to better align with potential occupancy. Erin committed to communicating via e-mail:
