How the potential IPAC lapse was identified: Complaint

Summary description of the IPAC lapse:

Observed furnishings made of absorbent material and in poor repair. Observed nail tools/equipment/surfaces/linens improperly cleaned, disinfected and/ or laundered. Observed no dedicated cleaning brush. Hand hygiene not performed by staff and adequate hand hygiene supplies not provided. Observed nail implements and items improperly stored. Chemical containers not labelled appropriately. Observed contents of sharps container above the fill line. Clients not directed to wash hands prior to service.

IPAC Lapse Investigation

Did the IPAC lapse involve a member of a regulatory college? No

Concise description of the corrective measures required:

- Operator to ensure all furnishings, work and contact surfaces are made of durable, smooth, non-absorbent, easy to clean material and maintained in good repair.
- Operator to launder linens after each use.
- Operator to ensure all surfaces are kept clean and in a sanitary manner.
- Operator to practice hand hygiene before and after service delivery and as often as necessary to prevent disease transmission.
- Operator to ensure a 70-90% alcohol-based hand sanitizer is provided and within reach wherever personal services are provided.
- Operator to store items in clean, covered containers.

- Operator to store all nail implements and equipment in a sanitary manner.
- Operator to ensure chemical containers are properly labelled.
- Operator must discard full sharps container once it reaches the fill line or ¾ capacity.
- Operator to properly clean and disinfect all reusable nail implements after each client.
- Operator to clean reusable implements by using a clean, dedicated brush with detergent and water and friction to remove debris prior to disinfection.
- Operator to ensure all implements are properly disinfected with an appropriate level of disinfectant.
- Operator to ensure client's hands are cleaned with soap and water or alcoholbased hand rub (if hands are not visibly soiled) prior to service.
