COMMUNITY HOMELESSNESS REPORT SUMMARY

Region of Durham

2023-2024

The Community Homelessness Report (CHR) is an annual Reaching Home reporting deliverable that supports communities to prevent and reduce homelessness using a more coordinated, systems-based and data-driven response. The CHR was designed to support local discussions and decision making, using all of the information about homelessness currently available at the community level. Communities are encouraged to use their CHR data to develop clear plans of action that help them to reach their homelessness reduction targets and to leverage the collective efforts of service providers working across the community, regardless of how they are funded.

This is a summary of the CHR for the 2023-24 reporting cycle. It shows the community's self-assessment of Reaching Home implementation, which includes the following key components:

- meaningful collaboration between Indigenous and non-Indigenous partners (see Section 1);
- community-level governance, coordinated service delivery (Coordinated Access) and use of a Homelessness Management Information System or HMIS (see Section 2); and,
- an Outcomes-Based Approach (tracking community-level outcomes and progress against targets using person-specific data; see Section 3).

If the community was able to report on outcomes and targets, this CHR Summary also includes results for each of the five core outcomes of Reaching Home (see Section 4).

Our community continues to maintain and improve our Coordinated Access System, By-Name List and HIFIS Database. Continous improvements include:

- Monthly meetings with our Built for Zero Canada Improvement Advisor to work collaboratively on improvement projects for the system, review data, and create goals and plans.
- Continuous collaboration with external organizations such as the Canadian Alliance to End Homelessness and OrgCode to work on improvements to the system, share best practices, and have our system externally reviewed to identify areas of improvement.
- Connecting with other communities across the Province and Country to share best practices, research, tips, and learnings about Coordinated Access, the By-Name List, and HIFIS.
- Overseeing six sector tables that meet bi-monthly to target various areas of our Coordinated Access system to ensure ongoing feedback and improvement projects from our partners in the homelessness sector.
- Engaging with people with lived and/or living experience to receive feedback on various areas of the system for improvement and to inform future policies/ procedures. This includes having representation on the Durham Advisory Committee on Homelessness, our overhead Governance body, as well as Sector Tables and working groups as needed.
- Ongoing in-person HIFIS training to ensure all agencies are using HIFIS and the By-Name List in a consistent manner.
- Ongoing in-person site visits by Regional Program Coordinators to complete Program Reviews, receive feedback on the Coordinated Access System and make improvements to the system.


Describe the process(es) used by service providers to collect and enter data about people currently experiencing homelessness into the database.

Service providers are entering data into HIFIS routinely with identified staff as data leads frequently reviewing their data for accuracy and integrity. Data accuracy confirmations, along with data integrity checks from our team occur quarterly to review program data and address any discrepancies found, with further training on specific modules as necessary. Service providers are collecting and entering their data via electronic or paper intake documents, with data entry into HIFIS.
