## Policy and practice update

## **Mandatory training**

A huge shoutout to all staff for their dedication and hard work in completing the 2024 training— what an incredible achievement with a flawless 100 per cent completion rate!

## **Program improvements**

All program committees have been actively working to enhance the services at our homes. Learning needs assessments for 2024 have been completed and the training team is currently reviewing the results to prepare the divisional training plan.

#### Skin and wound care education

We are focused on improving skin, wound and continence care within our homes. Clinical Leads Kim Burns, Chrystol Kennedy and Brett Chiasson will participate in the Skin Wellness Associate Nurse (SWAN™) Program, which is part of the Ministry of Long-Term Care initiative. Additionally, Jean San Luis, Manager of Nursing Practice at Hillsdale Estates, is pursuing education as a Nurse Specialized in Wound, Ostomy and Continence (NSWOC). These initiatives are designed to enhance shared expertise and improve care for the residents.

## Fall prevention and management

The Fall Prevention and Management program is preparing for a policy review this year.



## Pain management

Our Pain Management program will focus on enhancing training and compliance related to pain management.

#### Palliative care

Training will highlight a palliative approach to care, with collaborative palliative projects taking place at Hillsdale Estates and Fairview Lodge.







## Student placements

We continue to welcome students from various disciplines. Between January and December 2024, 289 student placements took place across the four homes and the divisional office.





#### Research collaborations

Our research collaborations on Virtual Reality Reminiscence Therapy (VRRT) and exergaming with Ontario Tech are ongoing. Ontario Tech has gathered feedback from our teams to make the prototype more user-friendly. As the studies progress, there will be opportunities for staff, residents and families to provide input.





## **Infection Prevention and Control**



The cold months are almost behind us as we look forward to spring and summer. The past few months carried high activity in our community of respiratory viruses (COVID-19, influenza and respiratory syncytial virus) as well as gastrointestinal viruses such as norovirus. As a result, we saw an increase in infections and outbreaks in our long-term care (LTC) homes. The LTC homes monitored this activity closely and implemented measures as needed to help mitigate the spread of infection. Some homes implemented universal masking for staff and visitors to help keep our residents, staff and visitors safe during these times of higher infection rates and outbreaks. We thank you for your diligence in wearing a mask and staying home when ill to keep everyone safe.

Wearing the appropriate personal protective equipment (PPE) is also an important measure if you are visiting a loved one who is ill or in isolation. If you see PPE outside of your loved one's room, please ensure you wear all the appropriate PPE that is listed on the sign attached to the resident's door. This will help keep yourself and others around you safe. If you have any questions regarding the PPE required, please speak to your home area's Registered Practical Nurse or Registered Nurse when visiting.

#### Candida auris

#### What is it?

Candida auris (C. auris) is a fungal pathogen that is often resistant to several different treatments and disinfectants. C. auris can infect any body part, including the blood, a wound and be found on an infected person's skin. Signs and symptoms depend on the location and severity of the infection, but may include chills, fever or extreme lethargy.

Cases of C. auris have increased in many different parts of the world, including the United States. Cases in Ontario remain low at this time, however due to the increase in cases seen in other parts of the world, Ontario has designated C. auris as a disease of public health significance. Cases will continue to be monitored closely with our local public health unit.

As an added safety measure, our four long-term care homes will be screening new admissions and re-admissions from other health care facilities (i.e., a return from hospital) for C. auris. If a resident fails the screening tool, then contact precautions of personal protective equipment may be initiated, along with a test performed to rule out C. auris infection.

## **Caring Connections Durham update**

# Exciting update: Launch of the "Change Ideas" phase for Caring Connections Durham at Lakeview Manor

We are excited to announce the launch of the "Change Ideas" implementation phase for the Caring Connections Durham Pilot Project at Lakeview Manor this February. This marks a pivotal moment in our project as we shift from planning to action.

In January, Beaver River staff participated in a two-day training session designed to equip them with essential tools and strategies to enhance the social and emotional well-being of our residents. This training will lay the foundation for the changes we are now implementing.

Our approach involves rolling out two change ideas per week. This allows the project team to gather valuable feedback from staff, residents and families, enabling us to adjust before introducing changes to other resident homes.

In February, we've already rolled out several key initiatives, including:

- Noise Reduction and Stress Management: A focus on reducing noise and stress in the dining room to create a calmer, more comfortable atmosphere.
- Engagement Enhancements: Introducing activity placemats to support residents who benefit from additional engagement before meals.
- "All About Me" Form: A newly updated version of this form is now in use, helping staff better understand the unique preferences and needs of each resident.
- Community Connections: We're excited to connect our residents with local schools and organizations in Beaverton through intergenerational programming.

Looking ahead, the project team will soon focus on:

- A new resident orientation program.
- · Job opportunities for residents.
- An early breakfast dining initiative.
- Environmental enhancements, including personalized doors and the addition of vibrant murals.

The project will continue to evolve as we incorporate ongoing feedback from staff, residents and families to assess the impact of our new care model. In the coming months, we will expand training and project implementation to the entire home, and we're eager to witness the positive effects this initiative will have on our residents, families and staff

## **Family Council**

## January 8, 2025, Family Council meeting

At our January 8, 2025, meeting, Joanne Iacono, Manager of Divisional and Community Supports, presented the results of the 2024 Resident and Family Surveys. 65.8 per cent of eligible Terraces residents who were able to respond rated their overall satisfaction at 80.9 per cent. The family response rate was 33 per cent, with an overall satisfaction rate of 89 per cent. Resident and family feedback through these surveys is used by the home Leadership Team to identify opportunities to enhance programs and services provided to residents at the Terraces.

Lisa Mizzi, Administrator, also attended our meeting and introduced Melissa Lombardi, Acting Director of Care, to families. Welcome to the Terraces, Melissa! Lisa provided an update on the changes to Personal Support Worker (PSW) staffing that were recently implemented, to provide continuity and consistency of care to residents. Family Council welcomes the new PSWs to the Terraces, and wishes them all the best as they get to know and care for our residents.

## February 12, 2025, Family Council meeting

At our February 12, 2025, meeting, we welcomed Corrine Lathangue, Falls and Restraints Clinical Lead. Corrine outlined the falls prevention strategies being introduced to further reduce resident falls. Although resident falls are trending downward, they continue to be above the provincial average/benchmark.

Emila Siwik, Infection Prevention and Control (IPAC) Practitioner, provided her final IPAC update to families before she leaves her position on February 14, 2025. Family Council thanks Emila and wishes her all the best in the future. Emila introduced our new IPAC Practitioner, Nguden (goo-den) Kwaghbo, who has a Bachelor of Public Health degree and is currently working on her Master's. Nguden comes to the Terraces from Manitoba, and she provided families with her experience in Public Health and Long-Term Care. Welcome to the Terraces, Nguden.

## March 12, 2025, Family Council meeting

At our March 12, 2025, meeting, Sean Bailey, Manager of Environmental Services, will introduce Kyle McLaughlin, Supervisor of Environmental Services, to families. Welcome to the Terraces, Kyle!

Sean and Kyle will review on-site and off-site laundry processes, the importance of labelling resident clothing and belongings, and the process for reporting missing items. Laundry staff perform closet audits throughout the year to capture items placed in the wrong closet and unlabelled items. This process has reduced the amount of missing clothing reported. Families were reminded that clothing is laundered at a water temperature of 160 degrees Fahrenheit, as set out by Public Health Ontario. It is for this reason that clothing made of durable materials such a cotton/polyester blend be purchased for residents.

## **Therapeutic Recreation Month**

February was Therapeutic Recreation month. Family Council would like to thank our dedicated Recreation and Therapy staff for providing meaningful and stimulating activities to our residents.

Every month, activity calendars are full of opportunities for residents to socialize and engage their physical, emotional, cognitive and spiritual needs. Family Council is happy to collaborate with the Recreation and Therapy team through our sponsorship of musical events and the annual garden party during the year.




#### **Residents' Council**

## **Celebrating the Food Services Team**

We shone a well-deserved spotlight on the dedicated Terraces Food Services Team during Pride in Food Services Week from February 3 to 7. Food Services hosted a kitchen open house to give staff a behind the scenes glimpse of our operations. We also held several events to recognize the hard work and dedication of our Food Services team.

Here are a few interesting facts about the Food Services Team:

- The Food Services department consists of four chefs, 44 food service aides, one maintenance worker, two food service supervisors, one clinical dietitian and one director.
- Food Services prepares over 600 resident meals daily, which adds up to 219,000 meals per year. In addition, Food Services provides resident snacks three times a day.
- Across eight dining rooms, we offer therapeutic and texture modified foods, as well as thickened fluids to meet residents' nutritional needs.
- Resident menus are three weeks in length and change seasonally.
- Food Services staff are required to have current Food Handler Certification.
- Food Services holds monthly Resident Food Committee meetings to gather feedback.
- Surplus food is donated to a community agency that supports those in need in Durham Region.

#### **March is Nutrition Month**

National Nutrition Month in Canada is celebrated during the month of March. This annual event is organized by Dietitians of Canada to highlight the importance of nutrition and promote healthy eating habits. During Nutrition Month 2025, dietitians across the country will come together to recognize their diverse roles in influencing the well-being of Canadians. Dietitians work across all areas of food and nutrition, including long-term care, to address the nutritional needs and challenges of the many varied and unique communities they serve.



## Cable television update

We heard you! On February 5, after approval by the Hillsdale Terraces Residents' Council, we implemented an update to the bulk cable services channel line-up. MTV, MuchMusic, YTV and BNN Bloomberg were swapped out for CNN, Turner Classic Movies, Flavour TV (formerly Food Network) and Showcase. Monthly cable rates will remain unchanged. In late February, we were able to complete the necessary infrastructure changes to restore Rogers as a choice of cable service provider to residents. If you are currently subscribed to the Bell bulk cable package but would prefer to switch to Rogers (and by the going market rate for their services), you can contact the Business Office to be disconnected from the Bell service. Residents or their family members will need to contact Rogers directly to set up a new,

personalized cable package.
